Introduction

Personal Information We Collect

We collect personal information when you make an inquiry on our website. This may include:

- Contact details (e.g., name, email, phone number)
- Event preferences (e.g., booking request, type of event)

We do not process any payments on our website; any payment transactions are handled offline. We use this information solely to respond to your inquiries and provide relevant event details.

How We Use Your Information

We use your information to:

- Process event bookings and inquiries
- Communicate with you regarding your bookings
- Improve our website and services
- Send marketing communications (if you opt-in)

Cookies and Tracking Tools

Our website uses cookies to enhance your user experience. These may include:

- Session cookies for website functionality
- Analytics cookies to track website performance (e.g., Google Analytics)
- Marketing cookies for targeted ads

Third-Party Tools and Links

We may use third-party services (e.g., Google Analytics, payment processors) to help manage our site and services. These services may collect data on our behalf, subject to their privacy policies.

Liability Disclaimer

While we strive to provide the best entertainment experience, we are not responsible for any accidents, injuries, or damages that may occur during our events. Clients are responsible for ensuring the event space is safe and secure.

Third-Party Services

We may collaborate with third-party vendors (such as caterers, DJs, etc.) for some of our events. However, Entertainment for Hire is not liable for the actions or services provided by these third parties.

Event Cancellations

We reserve the right to cancel an event if there are safety concerns or if it does not meet our conditions for a safe and enjoyable experience.

Terms and Conditions

Booking and Payment Terms

To secure your booking with Entertainment for Hire, a deposit of 25% is required upon receiving the invoice. Full payment is due at least 14 days before the event date. The deposit is non-refundable if the event is cancelled within 14 days of the event.

Prize Packages

Prize packages, if selected, are offered as an optional add-on. Entertainment for Hire is not responsible for third-party prize suppliers, and any issues with prizes should be directed to the respective supplier.

Event Extensions and Additional Costs

If you wish to extend the event, this can be done in one-hour increments. Additional charges will apply and must be paid in full before the end of the event.

Client Responsibilities

The client is responsible for ensuring the event space is safe. If any equipment or tables are damaged during the event, the client will be charged a fee for repair or replacement.

Respectful Behaviour

We ask that all clients and guests treat our Game Table Hosts with respect throughout the event. Any disruptive or disrespectful behaviour may result in the immediate termination of the event, and no refund will be provided.

Liability

Entertainment for Hire is not liable for any injuries, damages, or losses sustained during the event. The client agrees to indemnify Entertainment for Hire against any claims resulting from the event.

Third-Party Vendors

If third-party services are involved (e.g., catering, music), Entertainment for Hire assumes no responsibility for their performance, and any issues should be dealt with directly with the third-party vendor.

Event Cancellations
